We would like to remind all residents that dogs are NOT allowed on the clubhouse grounds at any time. And, as a reminder, all dogs must be leashed when not on your property. We have many residents that enjoy walking around our beautiful neighborhood. If you walk your dogs, please pick up all dog droppings. We have had a few complaints about dog droppings not being picked up. Thank you.

Big news!! After much diligent research, we have found a company that will be taking on the job of renovating our pool enclosure, which the community voted to have redone due to the deterioration of said enclosure. The company is NEPA Builders LLC. In order for them to start the work, we need an engineer's approval that the structure and the materials that NEPA will be using are sound enough for our climate in the Poconos. The engineer was here on 2/23/23 and needs about two weeks to draw up the plans. We will keep you posted on the progress of this long-awaited project. Unfortunately, during the renovation the clubhouse grounds will be completely off limits to the community due to safety concerns. This project is projected to take approximately 8 weeks.

Snack Bar will be open this summer during pool hours for snacks and drinks. All sales benefit the Recreation Committee.

Opening pool weekend is Memorial Day Weekend. Pool opening day is Saturday May 27, 2023 (tentative to work completion). There will be a pool party and covered dish on Sunday, May 28th from 2pm to 6pm (tentative to work completion). Pool hours 12:30pm to 7:30pm, 7 days a week. REMINDERS from your COVENANTS COMMITTEE

- Any unregistered vehicles are not permitted on public (state) roads as defined by the Pennsylvania Department of Motor Vehicles which includes the public roads of Birch Hollow Estates. This includes, but is not limited to ATV's dirt bikes, etc.

Resale Certificates






Resale certificates are available for a fee by calling our Managing Agent, Cal Bird at 570-420-7535. The processing time for a certificate is approximately ten days.

If you have unpaid property assessments, which were due by February 15 to not be considered late, and to avoid any further late fees, which increase from \$20 to \$40 on March 15, please reach out to the business manager at your earliest convenience. Thank you.
- Parents/guardians please park as far off to the sides of school bus pickup/drop off zones to not block other cars from being able to pass. We have had multiple complaints and its an easy fix to share the busy morning roads.
- Residents, children, and pets will be out and about more with warmer weather so please remember to adhere to our speed limits of 25mph and not running stop signs.
- ATTENTION: as per Chestnuthill and Polk Township ordinances, open burning of materials is strictly prohibited. No person shall burn, ignite, incinerate, maintain, or otherwise permit any fire upon any of the streets, roads, alleys and/or public rights-of-way. Recently, an open, unattended leaf burn was found to be occurring on the Watercrest median runoff area. Thankfully it was extinguished, and authorities were called before it caused a problem. Please practice vigilance and safety in our community and stay familiar with our township ordinances. Thank you!
