Resale Certificates



When you sell your house, you are required to provide the buyer with a resale certificate before going to contract. The Resale Certificate ensures that the buyer has been notified of our Association, its By-Laws, and Covenants. Resale certificates are available for a fee by calling our Managing Agent, Mary Ellen Revans at 570-420-7535. The processing time for a certificate is approximately ten days.

Need to Host a Party?

VP's Corner

What is this all about - NATIVE PLANTS??

My Son, Todd, found out about it at a church where the Native Plant Society was planting native plants in their garden. At this event he was given a book by Doug Tallamy entitled "Nature's Best Hope, A New Approach to Conservation That Starts in Your Yard." He learned a lot from the book and he is teaching me now.

So, what is a native plant? The textbook definition is they are the plants that have been growing in our area prior to European settlement. Our Pocono Mountains have many trees, shrubs and wildflowers that have adapted to our local environment, such as: Oak trees- which supports over 4,000 different species of insects and animals.; Mountain Laurel shrub which is our state flower with pink and white flowers; we have beautiful and abundant ferns here in BHE; and we have Goldenrod which is a nectar source for pollinators (which is how plants make seeds to grow new plants). Pollination is a very important part of the life cycle of plants. Insects, birds, bats, and the wind take pollen between flower plants, which means the plants can make seeds and reproduce (have babies!).

A native plant needs less fertilizer and pesticides and they help insects pollinate. They need less water which means less erosion, which helps us protect our streams and wells.

The opposite of a native plant is called an invasive plant. This plant is capable of moving aggressively into our area and using our light, nutrients, water, and space and killing our native plants. Invasive plants are a significant concern in the Poconos, impacting the local ecosystem by outcompeting native species and disrupting natural habitats. Some of the most common and problematic invasive plants in our region include Japanese barbery, Japanese stiltgrass, Callery pear, garlic mustard and Japanese knotweed.

My son is putting in a native plant garden in my fenced in pen, we are planting native trees and bushes in my yard and we are working on getting rid of the Japanese barbery on my property. Never too old to learn something new! Another great resource is: homegrownnationalpark.org.

REMINDERS from your COVENANTS COMMITTEE

- All vehicles must be parked on your own property, not on the edge of the road or on the grass
- All dogs must be leashed, always, when they are not on your own property. Dogs running loose scare and can hurt walkers, joggers, bike riders and leashed dogs on a walk. Do not allow dogs to do their business on neighbors' properties. Dog owners are responsible to always clean up after their dog. Dogs are required to be licensed and vaccinated.
- The speed limit in our community is 25 mph. There are families, kids, and pets out and about with the warmer weather. Please, watch your speeds.
- Any unregistered vehicles are not permitted on public (state) roads as defined by the Pennsylvania Department of Motor vehicles which includes the public roads of BHE. This includes, but is not limited to ATV's, dirt bikes, etc.
- Trash cans must be removed from roadside once your pickup is complete for the week. They may not remain at the roadside all week. Please ensure your cans are off the road when placed at roadside for pick up.
- All tree removal within BHE requires board approval prior to removing trees. An approval form may be obtained from our office. For structure permit questions, please refer to the chart at the clubhouse.
